**Barry Garnham** then gave a fascinating demonstration of cutting and assembling a coloured glass panel. The process starts with a paper plan with lines for the glass joins. Glass is cut using a diamond cutter and special pliers. Lead comes in 6ft. "canes" and when stretched becomes strong enough to stay rigid. It is lined up round the glass pieces, opened up and the glass fitted in, held in place with horseshoe nails. The lead is folded over and soldered at the joins, tallow having been rubbed into the soldering areas to prepare the lead. The solder strip is composed of tin and lead mixed. Finally leaded light cement is used to fill the gap between the glass and lead strip, which also waterproofs the panel. Barry is kindly donating the panel he made to the Society and it will be on view at future meetings.
